SENIOR CITIZEN VOLUNTEER REBATE PROGRAM
APPLICATION & REGULATIONS**

1. For the purposes of this program, a senior citizen is defined as being 65 years of age or older.
2. A person (or family) can earn a tax rebate up to \$650 per year or the amount of their school real estate tax; which ever is less, for volunteer services.
3. The rebate is available only on that property which is the principal residence of the volunteer(s) in the Oxford Area School District.
4. All volunteers must apply for a Federal Criminal History Record Check (Act 114), a PA State Police Criminal Background Check (Act 34) and a Child Abuse History Clearance (Act 151), for which the application fees are the responsibility of the applicant.
5. No liened properties are eligible for rebate.
6. All rebates will be issued on June 30th, following the lien date for the current tax year.
7. Senior volunteers will not replace or supplant existing jobs or positions.
8. The scope of the program will be determined by a budget annually approved by the Board of School Directors.
9. The District reserves the right to discontinue the program at any time. Should this happen, participants will be given tax credit for their hours of service.
10. Participants will be asked to complete a W-4 and an I-9. Distributed funds will be reported to the IRS.
